Councillor Jozsa reported on pesticide screening and dandelion control, including proposals for both a 'groundwater investigation for pesticide screening' and a more natural approach for weed (dandelion) control.

Admin Assistant Hurlburt reported on the summer students, Canada Day final report completed, Shand Greenhouse application completed, weekly meetings with staff, working on sign orders, correspondence and various input from ratepayers.

Councillor Montgomery reported on the Mistusinne Charity Golf Tournament, held August 15th. They had 81 golfers registered. Donations were made as follows: STARS \$228 from the 50/50 draw; Elbow Volunteer Fire Department \$1,600, and the Elbow First Responders \$1,600.

Councillor Peterson reported on his research into re-capping the tennis courts and that he will continue to get pricing.
