A BYLAW OF THE RESORT VILLAGE OF MISTUSINNE TO ENTER INTO AN AGREEMENT WITH THE VILLAGE OF ELBOW TO PROVIDE 911 FIRE COVERAGE

The Council of the Resort Village of Mistusinne, in the Province of Saskatchewan, enacts as follows:

- That the Resort Village of Mistusinne is hereby authorized to enter into an agreement with the Village of Elbow through Sask 911 to provide fire protection as detailed in the attached schedule hereto forming part of this bylaw and identified as schedule 1, effective January 1, 2020.
- 2. That effective January 1, 2020, Bylaw No. 01-18 is hereby repealed.

Memorandum of Agreement made this 16th day of May 20 20

Between:

the Resort Village of Mistusinne

(hereinafter referred to as the 'Mistusinne')

and

the Village of Elbow

(hereinafter referred to as the 'Village')

This agreement witnesses as follows:

WHEREAS with the implementation of the 9-1-1 system it is desirable to have an agreement with local fire departments to provide fire protection services to every area in Saskatchewan.

WHEREAS the Village has agreed to provide fire protection service for a fee, within an area surrounding the Village of Elbow, whose boundaries have been agreed to with neighbouring fire departments.

THEREFORE

- The Village agrees to provide fire protection services within the corporate limits of the Resort Village of Mistusinne.
- 2. The parties to this agreement further agree to the following terms and conditions:
 - a) The Village will provide training for its fire department members.
 - b) The Village will provide for storage and maintenance of its equipment.
 - c) The Village will be responsible for providing insurance on its fire fighting equipment.
 - d) The Village Fire Chief or his designate is responsible for prioritizing fire calls.
 - e) Mistusinne will pay an annual levy of \$1,800 (one thousand, eight hundred dollars) to the Village to be on call for emergency fire fighting response.
 - f) Mistusinne, or the individual ratepayer, as the case may be, may be charge for any additional response from other Fire Departments or EMS if dispatch or the Village Fire Chief deems that response is necessary.
 - g) There will be no additional charge to Mistusinne or residents of Mistusinne for the Village to respond to emergency fire calls within the corporate limits of Mistusinne other than what has already been detailed within this agreement.

 It is understood and agreed that this agreement shall commence on January 1, 2020 and continue until December 31, 2021, when it shall be reviewed and renewed if the parties are in agreement.

4. This agreement may be terminated by either party to the agreement giving thirty days notice in writing.
