**A BYLAW OF THE RESORT VILLAGE OF MISTUSINNE TO ENTER
INTO AN AGREEMENT WITH THE VILLAGE OF ELBOW TO PROVIDE
911 FIRE COVERAGE**

The Council of the Resort Village of Mistusinne, in the Province of Saskatchewan, enacts as follows:

1. That the Resort Village of Mistusinne is hereby authorized to enter into an agreement with the Village of Elbow through Sask 911 to provide fire protection as detailed in the attached schedule hereto forming part of this bylaw and identified as schedule 1, effective January 1, 2025.
2. That effective January 1, 2025, Bylaw No. 02-20 is hereby repealed.

Schedule A of Bylaw No. 02- 2025

Memorandum of Agreement made this 15th day of February, 2025

Between: the Resort Village of Mistusinne
Box 160 Elbow SK S0H 1J0
(hereinafter referred to as the 'Mistusinne')

and

the Village of Elbow
Box 8 Elbow SK S0H 1J0
(hereinafter referred to as the 'Village')

This agreement witnesses as follows:

WHEREAS with the implementation of the 9-1-1 system it is desirable to have an agreement with local fire departments to provide fire protection services to every area in Saskatchewan.

WHEREAS the Village has agreed to provide fire protection service for a fee, within an area surrounding the Village of Elbow, whose boundaries have been agreed to with neighbouring fire departments.

THEREFORE

1. The Village agrees to provide fire protection services within the corporate limits of the Resort Village of Mistusinne.
2. The parties to this agreement further agree to the following terms and conditions:
 - a) The Village will provide training for its fire department members.
 - b) The Village will provide for storage and maintenance of its equipment.
 - c) The Village will be responsible for providing insurance on its fire-fighting equipment.
 - d) The Village Fire Chief or his designate is responsible for prioritizing fire calls.
 - e) Mistusinne will make an annual grant of \$2500.00 to the Village for maintenance and purchase of fire-fighting equipment.
 - f) The Village will charge the Resort Village of Mistusinne a \$975.00 call out fee plus \$156.00 for the first hour and \$130.00 per hour or part thereof for fire calls outside the Village of Elbow corporate limits.
3. It is understood and agreed that this agreement shall commence on January 1, 2025 and continue until December 31, 2025, when it shall

be reviewed and renewed if the parties are in agreement.

4. This agreement may be terminated by either party to the agreement giving thirty days of notice in writing.
