## Council Meeting Highlights

December 14, 2025 meeting.

Council approved the minutes of the November 22, 2025 regular meeting of council. These are available on our website. The next regular meeting will be held Sunday, January 18 at 12:00 p.m. at the Municipal Office. Council members may choose to attend electronically weather dependent.

There were no delegates to the meeting.

Operations Manager Edward Stenko presented his verbal report. Snow removal is well underway for the season. He has begun to work on planning for 2026 projects as per recent strategic planning meetings. The old wooden playground structure has been removed for safety reasons.

55 more surveys were completed. The survey is now closed. 173 surveys were completed. Thank you for everyone who participated. The results will be available on our website shortly.

Council discussed the proposed zoning bylaw again. Further discussions will occur at the Jan meeting. Council is revamping the bylaw regarding septic tank protocol. Further discussions will take place in Jan.

All 2025 payments are due by 4:00 p.m. Friday, Jan 2, 2026. Have you paid your lagoon access, and irrigation fees?

There is an AED machine located on the front of the building. Do you have the proper training to utilize the machine if needed? If so, would you be willing to have your name listed on an [in case of emergency contact information list]? If so, please email the office.

The Calendar of events for the year is underway, and will be online shortly. Mistusinne Morning will be Sat, May 16 from 9 a.m. – 11 a.m. May 31 will be tree cutting and planting day. Garage Sale Day July 4. Clean-Up days will be July 17-19. Water Testing day will be July 19. Canada Day July 1, and Aug long entertainment Sun, Aug 2.

Our Mayor, and members of council, and staff attended a Fire Meeting in Elbow. Fire protection fees will be increasing this year for all municipalities. New this year council is considering adding a Fire Protection Fee of \$25.00 per property. This fee would be invoiced with the lagoon access, and irrigation fee. The 2026 annual fees would be \$341.00 per cabin if approved. Further discussions, and potential implementation will occur at the Jan meeting.

The 2026 Budget, Base Tax, Mill Rate, discounts, and penalties will be finalized at the Jan meeting. Council is considering raising the Mill rate from 1.87 to 1.97 mills. This will cause an increase in the range of \$10.40 to \$52.72 per property.

Council reviewed the November Financials. Accounts payable to date were approved. Correspondence from SUMA regarding the annual fire fights volunteer insurance renewal was received.
