Council Meeting Highlights

January 18, 2026 meeting.

Council approved the minutes of the December 14, 2025 regular meeting of council. These are available on our website. The next regular meeting will be held Sunday, February 22, at 12:00 p.m. at the Municipal Office. Council members may choose to attend electronically, weather dependent.

There were no delegates to the meeting.

Operations Manager Edward Stenko presented his verbal report. Darwyn Hoyseth has taken over Snow Removal now that Ed is on layoff for the season. He will return March 1. The Blade is broken on the snow removal equipment and is in Loreburn for repair. The bush pile has been burnt.

Council passed the proposed Zoning Bylaw at this meeting. The bylaw will be forwarded to community planning for review and approval. The bylaw does not come into effect until approved by the province. The Bylaw will be posted online once finalized. The Official Community Plan has been approved as well. This bylaw will also be forwarded to the province for approval.

Council has passed a new Sewage Bylaw. Tank Dipping will no longer be completed by staff in October. Residents will be responsible for arranging their own end of year tipping of their septic tanks. Please take note of this change. Council will be on hand at Mistusinne Morning to answer questions.

The 2026 Operating and Capital Budget was approved at this meeting, and is available online for review. The Mill Rate for 2026 was set at 1.97 mills. The base tax increased by \$30.00 to \$730.00 per property. This will replace the proposed Fire charge debated at the December regular meeting.

Council will be hosting a Tree Cutting and Planting Day Sunday, May 31. Council is looking for parties who would willing to donate funds to help pay for said trees. Donation receipts can be provided. Administration has applied for grants, and will continue to do so. Council authorized administration to apply for both a MuniSoft Community Project Grant, and a SUMAAssure Community Sponsorship program to assist with the purchasing of trees.

The survey results are available on our website on the "What's New" section. Thank you to everyone who participated.

SAMA will be conducting a thorough reinspection of all properties in Mistusinne for the year 2027. They will be mailing a letter directly to you, with a form to complete. Please be sure to complete the form so your assessment will reflect accurately.

Administration has been busy working on year end. The 2025 financials will shortly be off to the auditor for review. Tax notices and fee notices shall be emailed out shortly. The discounts for 2026 will remain the same as 2025. Mistusinne Morning will be held Saturday, May 16 from 9-11. Please come on out and enjoy a donut! Over Christmas new clothing was designed and ordered through a new different company. You may try on sizes at Mistusinne Morning, and place orders at Mistusinne Morning. The orders will arrive in early June to the office for pick up, you may pick up once out for the season. Please note – these are different hoodies than previously so please be sure to have a look! The pictures and details will be available online.

New this year...There will be no physical golf passes. You will purchase your golf pass online through a new online portal and pay via ETransfer, Cash or Cheque. You do not need to come to the office for a pass. You will automatically be added to our list when payment is received. Golf Passes, Green Spaces, and Building permits will all be applied for online this year to help streamline processes.

Council is considering capital projects that would require corporate sponsorship to complete. This includes installing a concrete floor in the Gazebo.
